3. Show that you have upheld the principles and By-Laws of Sunnier
4. Have met with a member of the Management Committee for an orientation conference to review the By-Laws and Sunnier Agreements and agree to abide by them
5. Enlist the sponsorship of two (2) Resident General Members willing to befriend, discuss and guide applicant(s) in the concepts and practices of Sunnier Palms. Each Resident General Member sponsor must verify with their signatures that they have done so.
6. Pass a background check – Applicant(s) will provide information, along with being responsible for the cost of a criminal background check

*APPLICANT AGREES AND UNDERSTANDS THAT PRIOR TO PAYMENT OF A 2<sup>ND</sup> YEAR OF MEMBERSHIP, APPLICANT MUST COMPLETE THE GENERAL MEMBERSHIP APPLICATION, SUBMIT APPLICATION TO THE MANAGEMENT COMMITTEE TWO (2) WEEKS PRIOR TO THE NEXT SCHEDULED MEETING. APPLICANT, ALONG WITH THE SPONSORS MUST ATTEND THE NEXT SCHEDULED MANAGEMENT MEETING (THE MONTH PRIOR TO MEMBERSHIP EXPIRATION).
