

Covid Guidelines 2.15.22

1. ALL RESIDENTS, MEMBERS, AND CAMPERS upon arrival at Sunnier or returning to Sunnier after one week of absence will be required to have a temperature check (100.4+ requires quarantine for 5 days and an additional 5 days of wearing a mask) and must sign the Covid Statement below. In addition the following applies to ALL:

- Anyone can voluntarily provide proof of vaccination upon arrival. The individual will be required to sign a statement indicating he/she provided this information voluntarily.

OR

- Anyone will be required to have a covid test (test must be performed within 48 hours before arrival or 24 hours after arrival to Sunnier. The test result must be provided to the office upon arrival. If test result is not available upon arrival, the individual must quarantine up to 5 days while awaiting test result to be presented to the office.

OR

- Upon arrival anyone may quarantine for 5 days on their lot (this means NO use of any of Sunnier's facilities).

An individual, who has traveled by air or associated with anyone who has within the last 5 days, must follow the guidelines as listed above.

2. Social distancing and masks will be required in the Pavilion for Board and Committee meetings, when conducting business with the office, and when others present in the laundry room and public restrooms.

3. Day visitors and tent campers will not be permitted entrance to the park. Sunnier will only admit RVs with full facilities (water, electric and sewer)

4. GUESTS: Residents/Members are allowed to have guests. Guests of RV Campers will be handled on a case by case basis with the office. ALL guests are to be checked in by office staff. ALL guests are required to follow these Guidelines. If the guest wishes to not voluntarily show proof of vaccination or a Covid test, he/she will be required to ALWAYS remain on the Resident's or RV camper's lot.

THE ABOVE POLICY SUPERCEDES ANY PREVIOUS COVID GUIDELINES POLICY

Covid Statement

Out of an abundance of caution, Sunnier Palms remains under social distancing (6 ft apart) and masking guidelines. Mask and social distancing where possible are required in the Pavilion and when conducting business with the office. Abide by the posted Covid signs.

To ensure the park remains as safe as possible for our residents, members and guests, please read the following and sign acknowledging your understanding:

 1.I have NOT experienced any of the following symptoms within the past 5 days: fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting, diarrhea.
